Certification of the completion of our responsibilities as auditor for the year ended 31 March 2022

We have been unable to complete our review of the Annual Governance & Accountability Return (AGAR) for Icklingham Parish Council for the year ended 31 March 2022. The authority failed to submit the necessary information for our review.

Having exhausted all options open to us to attempt to obtain an AGAR, we therefore have no option but to certify completion and bring to an end our responsibilities as auditor for the year ended 31 March 2022. We have taken this decision reluctantly, as once completion is certified, public rights (such as the rights to inspect the accounting records and associated documents and to ask questions or make objections to the auditor) can no longer be exercised.

Fee

We enclose our fee note for the review, which is in accordance with the fee scales set by Smaller Authorities' Audit Appointments Ltd. Please arrange for this to be paid at the earliest opportunity.

Additional charges are itemised on the fee note. These arise where either we were required to issue chaser letters and/or exercise our statutory powers due to a failure to provide an AGAR (i.e. fees for statutory recommendations and/or public interest reports); or we had to send the AGAR back for correction due to a mistake or omission by the smaller authority; or we had to seek clarification and/or correction to supporting documentation due to a mistake or omission by the smaller authority; or it was necessary for us to undertake additional work; or we had to send back documentation that was not requested.
