#### 009/18 DISTRICT COUNCILLOR'S REPORT

DCIIr Burt had sent her report through via email, synopsis below.

The closing date for RAF Mildenhall has not changed from 2014, in fact it could be extended.

Modifications to the Local Plan will be looked at a hearing on 25<sup>th</sup> June at Forest Heath. Hopes are now that the Plan will be adopted in September.

Hatchfield, no decision to date, but in the last few days we have heard that the Secretary of State notes that over three years have now passed since the enquiry was held in April 2015, he considers that there have been significant changes in circumstances since the enquiry which are material to the re-determination of the proposal. The Secretary of State considers that reopening the enquiry would give all parties an opportunity to thoroughly test this updated evidence, including by cross-examination if necessary. We don't have a date for this enquiry at present. Refer to Gareth's letter.

One Council, orders have now been made and we are now working with the two Councils on the Shadow Council. On the 30<sup>th</sup> May we had the first meeting which was purely administrative, electing Chairman, Vice Chairman, Leader and Deputy Leader and Executive Cabinet. All meetings of the Shadow Council will take place at West Suffolk House as we at Forest Heath don't have enough room to accommodate 72 Members, Officers, Democratic Services Staff. These meetings will be on a monthly basis.
